- 2. The Institute shall abide by IMU's conditions of affiliation as laid down in its Act, Statutes, Ordinances, Regulations, Circulars, etc. and as amended from time to time.
- 3. The Institute shall not seek dual affiliation for the same course with the same name to any other University.
- 4. The Institute shall-maintain good sustainable academic standard commensurate with the needs of the international shipping and equip the students with the best of laboratory,

workshop and other facilities.

- 5. The Institute will have in place duly qualified faculty in accordance with IMU circulars in force.
- 6. The Institute shall have a Student Grievances Redressal mechanism in place.
- 7. Only such students who meet the eligibility criteria as prescribed by IMU shall be admitted by the Institute, any deviation will result in de-affiliation of the Institute by IMU.
- 8. The IMU shall be indemnified from any responsibility- legal, financial or otherwise and shall not be accountable / called in question and legally proceeded against for any reason whatsoever.
- 9. The approval is co-terminus with necessary approval from local bodies, State govt. including trade and labour regulations, Municipal Authority and such other authorities as may be applicable and clear land title where the Institute is located being submitted whenever called for,
- 10. The Institute shall be subjected to scheduled / unscheduled inspections by the representative(s) of the Indian Maritime University. In case of any serious deficiency, the provisional affiliation shall be withdrawn without any further notice.
